How you get paid

Patients with credit challenges

- Some applicants simply will not qualify for the low costs financing options provided by our revolving credit products
- Applicants with credit challenges may apply for a traditional installment loan
- Installment loans provide a fixed interest rate and term and may also be utilized to supplement revolving lines of credit if the credit line is insufficient to meet the needs of the patient or customer

Applying for an Installment Loan

- A note will direct you to a link for www.mymedicalfunding.com our installment loan program
- Simply complete the application
- Receive an instant credit decision
- Review and select term
- Your loan is funded in 7 to 14 days

Revolving Credit vs Installment Loan

- Revolving credit establishes a specific line of credit that remains available. During interest free periods, 2% of the balance is due each month and is credited to the principal. After the interest free period, the payment increases to 2% plus the appropriate interest.
- Installment loans have specific terms or 12, 24, 36, 48 or 60 months and a set monthly payment due each month. Our installment loans do not provide interest free periods.

- Immediate credit decisions are given on all on-line applications.

Frequently Asked Questions

Q: How do I apply for the card?

A: To receive an instant decision, apply on-line at www.advancecarecard.com. Your instant response will also include your credit line.

Q: What will My Interest rate be?

A: Your interest rate will depend largely on your individual credit history. Interest rates which are in effect after the interest free periods are provided to the applicant at time of approval.

Q: What Does it Cost to Apply?

A: Applying for the Advance Care Card is free, and there is no obligation to use your account if you are approved.

Q: Are there any pre-payment penalties?

A: No. As long as you make the minimum monthly payment as required, you can pay you balance off at your own pace.

Q: What if my credit is not perfect?

A: If you have experienced credit challenges in the past, Advanced Care will work diligently with you to provide the best opportunity for approval.

Frequently Asked Questions

Q: As a provider, am I required to sign a contract to offer Advance Care products to my patients?
